Resolution By: M. Shutts Seconded By: W. VanRiper, Jr. WHEREAS, the Town of Erin Town Board is in receipt of a letter from the Town of Erin Highway Superintendent dated August 9, 2023 requesting consent from the Town Board to provide written consent to abandon a portion of Palmer Road; and

NOW THEREFORE BE IT RESOLVED that Town Board of the Town of Erin, County of Chemung, State of New York acknowledges receipt of a letter from the Town of Erin Highway Superintendent dated August 9, 2023 verifying that the portion of Palmer Road, including a portion also known as B Jones Road, in the Town of Erin, as shown on the attached Map, from the point of the intersection with Marsh Road and Chapman Road continuing in a northerly direction to the point of the intersection with South Greenbush Road has not been maintained as a highway nor used as a highway by the public for more than twenty (20) years; and

BE IT FURTHER RESOLVED that in accordance with New York Town Highway Law section 205(1), the Town Board hereby consents to hereby abandon the portion of Palmer Road, also knowns as B Jones Road, as described herein and directs the Town Supervisor to execute any and all necessary documents related to this declaration of abandonment and to file and record any such documents with the Town Clerk's office.

COMMITTEE REPORTS

Town Attorney- Finished the paperwork and resolution for Palmer Road that was just discussed. Planning Board- Deda Cedar- There was no meeting due to no quorum. Supervisor Schmidt asked about the policy with the bylaws. Deda thinks it states you can't miss three (3) meetings. One member was moved up to permanent. Supervisor Schmidt is going to work with the Town attorney and craft a letter regarding attendance and whether members are on or off the Planning Board. There are open permits that are over 60 days. John McCracken will check with the Town attorney to see where we need to go with this.

Parks, Recreation and Senior Committee-Deda Cedar- The Senior picnic was held at Park Station with 22 people in attendance. The Food Truck served 163 families with the leftover food going to the North Chemung Food Pantry. Park & Rec didn't have a meeting because Deda was sick. There is a gentleman in Town that is interested in doing a craft fair. Trying to organize that. She has not heard from Donna Vergason regarding the silo project. There have been a lot of negative comments. People say it does not look like the picture that was voted on. Supervisor Schmidt asked what the close out for Wood Fest was. Deda thinks it made a profit of over \$2000.00, but will check with Melody Shutts for the actual figure. A resident voiced his concern regarding a water flow issue from scrap lumber and wood debris from Wood Fest that was pushed into the creek. Both Supervisor Schmidt and Harold Spencer verified that it was cleaned out shortly after the festival. Councilmembers Evans and VanRiper, Jr. will look into the issue. The Senior committee has a trip planned to see a Charlie Pride tribute in Cortland on 9/14. They have 19 currently signed up and need 35 to go. The 19 people are Erin residents, but only one (1) person has paid so far.

Code Enforcement-John McCracken- He has been issuing permits. Questioned Board regarding 911 numbers on vacant pieces of property. The Board agreed that there needs to be a structure on the property. Discussed a possible music festival on Sandbank Road over Labor Day weekend with camping available. He has been in contact with the health department on options if it does take place.

Highway Superintendent-Steve Tyler- They have been grading roads and putting down dust control, ditching, trimming trees and fixing equipment. They got the new Case tractor and it is working very well. Two (2) house sites were cleaned up per Code Enforcement and contents were taken to the dump. Code Enforcement received two (2) separate bills for the cleanup. Steve would like to put the old

water truck up for surplus equipment and will take sealed bid offers to be opened at the next meeting. He would also like to put truck #3 up for surplus equipment to be put on RTI's auction site.

A motion was made by W. VanRiper, Jr. and seconded by A. Hughson to allow Steve to put the old water truck up for surplus equipment and accept sealed bids to be opened at the September Board meeting. Motion carried: Ayes: W. VanRiper, Jr., R. Evans, A. Hughson, M. Shutts, D. Schmidt. Nays: None.

A motion was made by M. Shutts and seconded by W. VanRiper, Jr. to allow Steve to put truck #3 up for surplus equipment on RTI's auction site.

A resident asked Steve about a street light on Church Street that has been out for two (2) years. It will be looked into this week.

Buildings & Grounds- Councilmember VanRiper, Jr. asked if the occupancy for the Town Hall was worked through. Supervisor Schmidt verified that is taken care of. Councilmember VanRiper, Jr. will be in touch with John O'Connor for a start date.

County Representative- Councilmember VanRiper, Jr. spoke on the County's agreement to pay for Park Station Road every 1-5 years and only paved half of it. Mark will check on that. The agreement was for \$25,000.00. It is budget season and the County Executive is potentially working on giving money to the towns and villages. The County Executive allowed the legislature to be involved in budget season for the first time. There is more insight and makes for a smoother process. The County purchased the old Five Star building and are consolidating about seven (7) departments. Looking at consolidations for the city. The IDA is controlling the arena. There is a management team that is working with the youth program, junior hockey program and the federal hockey league. One (1) sheet of ice will be eliminated and turf will be put down for indoor lacrosse and soccer. The IDA will control the income flow. Making it more of a community style facility and not just hockey. There are some discussions on doing renovations and upgrades on the fairgrounds with ARP funding. The Chemung County sewer project has gone from \$87 million to \$280 million. It is a huge, expensive project. The cost of goods, materials, and contractors that are required by the state have increased since the project was started. The system was never maintained properly over the years.

Supervisor Schmidt asked about the computer that was ordered in March for Code Enforcement that has not yet been received. Mark will follow up on that.

John McCracken, Code Enforcement Officer, talked about the County's GIS system that has not been updated in 7-8 months. It is a problem sending out violations and not knowing who the current owner is.

Supervisor- Dawn Schmidt- On the agenda, Josh Blauvelt was going to talk about the real property tax exemption public hearing that will take place Tuesday, August 15th at the fire department. This is New York's solution to help recruit volunteer firefighters. She encourages people to give input. There is a public survey on hazards that cause the greatest impact to Chemung County on the town website and also paper forms available. The survey takes about five (5) minutes to complete. The Chemung County Stormwater Coalition needs a stormwater coordinator from the Town for monthly meetings and to work closely with stormwater coalition team on projects and update our records.
