## **COMMITTEE REPORTS**

Town Attorney- Received revised version of the proposed Noise Ordinance from attorney. Pros and cons were discussed and comparisons were made on both the proposed Noise Ordinance from the attorney and the Good Neighbor Ordinance from the Planning Board. Also discussed: different hours on weekends, decibel levels, threshold, discretion of code enforcement/law enforcement, repeat offenders, and tiered penalties for offenses.

The document will be sent to the Town Attorney for a final review, once the final copy is received a date will be set for the Public Hearing.

Highway Superintendent- Authorization is needed from the Board to prove where CHIPS money will be spent. The agreement for the expenditure of highway moneys needs to be signed by the Board to blacktop Langdon Hill. Red Chalk is next year's project.

Supervisor- Dawn Schmidt- Sales tax will be cut at least 50%-60%; it could be as high as 75%. The Town has never used the County sales tax money to balance the budget. Comp Alliance supplied masks to the Town with a reminder to wear masks. A thank you note was received from Environmental Emergency Services for \$500.00 contribution.
