Planning Board Chair-Deda Cedar- The Planning Board reviewed the moratorium and sent it to the County. It should be on their November agenda. She received letters from some of the Town residents. Sean Reardon, Engineer for Clear Path and helps with SEQR review explained what is planned and what is being planned, topography issues, roadways, issues with the moratorium, the difference in various projects, panel size, distance between rows, and grid space.

Robert Romine, developer for Clear Path, their focus is to develop community-based projects. A letter of recommendation was provided from the Town of Tully. Talked on replacing transformers, capacity, replacing lines, significant upgrades to the grid.

Sean Reardon used a map and spoke on the Hughson solar project's fencing, panel size, spacing, panels that are static verses ones that move with the sun. Offered to generate any view of the project in order to see what the line of sight would be. Approximately 54 acres of land will be fenced in for about 10 acres of solar panels.

Greg Hering from Clear Path said they do have investors for these projects but they have not yet talked with DEC regarding water runoff. New York has strict storm water standards and permits are required. Storm water runoff is one of the hardest parts of the projects another is making the driveways. Robert Romine spoke on life usage of solar panels being 25-45 years, decommission plan, restoring land to original use. A debate ensued regarding tax revenue for the Town, IDA, PILOT, and host agreements. Jen Bau-Talked to multiple solar companies in the past. After two years of working with an attorney Clear Path approached them with a clear plan with their neighbors and views in mind. Jennifer and her husband went to seminars on solar, took their time and it is a well thought out project. She doesn't want the moratorium to affect this project and lose this company. Clear Path constructs the projects

themselves. It is a way for people that do own these big farms to take a tiny bit of land and make a profit out of it and leave the rest agricultural.

Supervisor Schmidt would like more input on those that do not want the projects. Would like to figure out a balance for the Town residents and innovation; to keep it rural and move forward at the same time.

Deputy Supervisor Delorme would like to see photos of completed projects.

Supervisor Schmidt informed Clear Path that the Town Board will not be the lead agency on this project. There needs to be a thorough process. Clear Path offered to pay for an attorney to run the whole SEQR process or a consultant to look over the project. The Town has questions and drainage concerns. There needs to be a happy medium; give and take on both sides. The Town cannot take on the burden for a private project. Part of the caution is people's view.

Clear Path offered to help with drafting a moratorium. More information is needed before moving forward. The Board will hold a Special Meeting and talk about concerns and ask questions. Have an exchange, a back and forth with pros and cons and come to a balance.

7:44 PM Councilman Randy Evans had to leave the meeting.

Stacy Stevens- Has 81 acres on Laurel Hill Road and would like to subdivide it into three parcels. Code Enforcement Office, John McCracken explained the process of a special use permit and the history of the property rule.

Town Attorney- No report.

Planning Board-Deda Cedar- She signed up for training on Zoning Board of Appeals at the Town of Horseheads on 11/16. Many towns are having issues with Boards and there is talk of shared services with ZBA. The Laviola subdivision was tabled until May. She spoke with the County planner and he will help in any way on the solar issues. Park Station needs to be protected; it is an asset to the Town and County.

Parks, Recreation, and Senior Committee-Deda Cedar- The Mobile Food Pantry served 153 people. The Christmas party will be 12/11 at 4:00 at the Fire Station. The Halloween party had about 60 kids. Sewing classes are going well. They will be applying for a grant that needs to be accepted by the Town on the silo project that is being headed by Donna Vergason. The Senior Group are planning their Christmas luncheon at Erin Fire Station on 12/7 at noon. They do not want any by-laws. There were 14 people at the October meeting and 21 at the November meeting.

Code Enforcement-John McCracken- He looked into the software and it is based off population. He is waiting for a clear number.

Highway Superintendent-Steve Tyler- Since the last meeting they have been ditching, installing pipes, patching potholes, trimming trees and working on equipment; getting ready for winter. They have also been hauling in antiskid. The ditch on Farr's property has been cleaned out. Planning on taking the Hometown Hero flags down and putting the holiday flags up.

Buildings & Grounds- Supervisor Schmidt asked for comments on the heating system-Councilman VanRiper, Jr. has concerns with the returns being in the conference room and the noise level, the units being outside and on stands. Would like to see them in the boiler room and pull fresh air from the boiler room wall that is already there and use standard equipment with an HRA unit to accommodate the fresh air act.

Chemung County Representative-Mark Margeson- Not at meeting. Mark Margeson won the election along with Joseph Donovan who is taking over Brian Hyland's half of our district.

Supervisor-Dawn Schmidt- Received a \$500.00 check from Comp Alliance due to zero insurance claims. Contract with Engie, a utility company, needs to be renewed by the end of December and she recommends doing that.

A motion was made by D. Delorme and seconded by M. Shutts to renew the energy contract with Engie that expires at the end of December.
