Joe was also advised to speak with Council Member VanRiper, Jr. prior to any work being done at the Park. Joe Frega reported that the October Wood Fest meeting had 5 people and there are 6 new people that are interested in helping out. Wood Fest will be 5/30-6/1. Steve Shutts will continue handling the grant applications and Melody Shutts will continue with the accounting. Trying to bring up the number of carvers to 20.

Gary Ratchford reported on the Senior Group-The Christmas party was at the fire station and was catered by Curly's. There was a secret Santa and almost 50 people attended. Elections were done and Kathy Broom and Gary Ratchford will be co-chairs, Roger Smith is treasurer and Deda Cedar will be secretary. The next Senior Meeting will be on New Year's Day.

Code Enforcement-John McCracken- The property on Fairview has been cleaning up the pallets after the fire. Trying to get in touch with the insurance company to let them know the house needs to be demoed. He is working with the attorney on that. A lien will be put on the insurance money and it will not be paid out until the Town is reimbursed. Talked about campers and having the definition in the zoning for seasonal campsites better defined. Need to have the number of campers allowed on a property and whether they are being used for camping or for storage. Issued a certificate of occupancy for a new home. A few new homes are in the works. Has been contacted by a few people who purchased lots on North Greenbush. No permanent homes have been scheduled yet. Every lot has been sold or pending. The new code cycle will be next year and he heard there will be a lot of changes in the new code.

Highway Superintendent-Steve Tyler – Since the last meeting they have been cleaning up trees, etc. after the storms. They have been working on equipment and plowing and cindering roads as needed. They took a load of scrap metal down and Steve has \$427.00 for the Board. The three (3) trucks that were on the auction site all sold for an approximate total of \$10,600.00. Two (2) of the trucks were picked up and the other is supposed to be picked up later this week. Once they are all picked up, Steve will call and have them removed from the insurance. Steve wished everyone a Merry Christmas.

Joe Frega asked Steve about the cost to stone the walking trail. Cost of stone is about \$18/ton without trucking and \$26/ton with trucking. Also questioned the stop sign at Rodburn and Church. He was told that the paperwork was turned in and we are waiting to hear back from the State. Steve will follow up.

Chemung County Representative-Mark Margeson- Not at meeting.

Supervisor-Dawn Schmidt- The City of Elmira has asked the Town to write a support letter to apply for a NYS Ag and Markets companion animal grant in order to build a new animal shelter in the City of Elmira.
